


Summit Lake Community Association

General Membership Meeting Minutes

SLCA FACEBOOK VIRTUAL GENERAL MEETING October 2, 2020 7:00 PM

President Edwards calls meeting to order.

Pledge of Allegiance

TREASURERS REPORT/MEMBERSHIP -DAVID DISHMAN -See Attachment Treasurers Report was approved and accepted.

MINUTES-JONI FUCHS -Reading of the Minutes were waved. Minutes were approved and accepted.

OLD BUSINESS

PHASE TWO of 4 ACRE PROJECT UPDATE–President Craig Edwards and Vice President Dwayne Swenson – SLCA would like to start Phase 2 of the 4 Acre project. This consists of the 20x20 covered Pavilion and finishing the RV spots. Budget is 8K. Added on the top is the purchase of interactive playground equipment (\$1500) that won't add to our insurance liability.

Building will not start until Spring as lumber prices are extremely high. We are asking for donations of material to help defray costs. The Pavilion will be located by the well head.

Motion is provided to the Membership as a motion with a second from SLCA Board. The membership will have till Oct 5th,2020 to vote on the motion. The budget is 8K for the building of the Pavilion and \$1500 for Playground Equipment.

Motion- The SLCA BOARD requests approval from the Membership to start Phase 2 of the 4 Acre Project with a budget of \$9500 Budget. Voting can be virtual, or by email, or in person. Voting will close on October 5^{th} ,2020.

SLCA GARAGE SALE -RECAP - President Edwards

A big thank you to the Community for donating to the Garage Sale. The Garage Sale was the biggest fundraiser SLCA has had to date. There was over 5k received and leftover items are still being sold online. Logo sales were also over \$5K. We received 11 new Members and over \$300 on the raffle! Thanks to everyone that has made this fundraiser such a success.

BOAT PARADE RECAP-Vice President Swenson

Parade was the best representation on the Lake yet. 13 Participants competed and fun was had by all. It has been rumored that several families have started planning for next year's 4th of July Parade!

FLAG PERSON STILL NEEDED- Craig Edwards

As of meeting time we did not have a Flag Person. Thank you to Eric and Renee Johnson for stepping up and agreeing to take it on.

RESULTS OF WDFW MEETING- Craig Edwards /Duane Inglin,

The three-year moratorium on stocking from WDFW has expired. WDFW will resume stocking 30K (3 – 10K increments) per year in 2021

INTERNET ABILITY AT CLUBHOUSE -DWAYNE SWENSON

Full time Internet is not feasible at this time as the cost is \$1800 a year.

NEW BUSINESS

CLUBHOUSE CLEANING

SLCA is looking for a group or individual that will deep clean the Clubhouse twice a year. It was suggested it could be done on Lake Clean-up Day and then also in the Fall after the picnic.

COMPLIMENTARY MEMBERSHIPS POLICY MOTION

The following motions are provided to the SLCA membership as a motion with second from the SLCA Board to be voted on at the October 2 General Meeting. Because of the necessary virtual nature of the meeting, these measures are put forth to the membership in advance of the meeting and can be voted on by return email prior to the meeting, or by contact through Facebook during the live streamed virtual meeting:

- Motion: Be it resolved that as of the 2021 membership year and following, all current complimentary memberships in the SLCA are hereby rescinded. Complimentary memberships with all rights and privileges of membership in 2021 and following years are limited to the following:
- 1. Floyd Japhet shall have a lifetime membership honoring his status as a founding member of the SLCA and predecessor organization, the Summit Lake Community Club.
- 2. The person managing the rental of the Summit Lake Community Center shall have complimentary membership during the membership year or years in which that service is performed.
- 3. The person managing the purchase and sale of the Summit Lake Logo items for the SLCA shall have complimentary membership during the membership year or years in which that service is performed.

PURCHASE OF A CONEX VAN/STORAGE SHED -CRAIG EDWARDS

Motion -The SLCA Board requests approval from the membership to purchase a metal "CONEX" type container of size approximately 10×20 feet to use for storage of SLCA materials, with spending authorization up to \$3500. Voting will close October $5^{\rm th}$, 2020

Pertinent information: The container would be a locking weatherproof box similar to shipping containers used on semi-trucks and ocean ships and can be purchased used occasionally from online sources at prices that range from \$1500 to \$5000, depending on condition and configuration. If approved, the SLCA board would shop for a decent container at the best price possible, not to exceed the approved price. The container would be installed on the SLCA property behind the existing pump house, but back slightly further into the woods. The board believes this would be a maintenance free and better option than trying to build or purchase a wood product storage shed, and would free up much needed space inside the clubhouse, and provide better security for items that are needed but infrequently used such as chairs and tables, and for additional items that may be procured in the future for outside activities.

THURSTON COUNTY FIRE COMMISSIONS MEETING RECAP-Craig Edwards

It was stated that in the Fall when Chief North came put to explain the Levy to us, he promised us if the Levy passed, we would get our Firemen. That did not happen.

Chief North was asked what were his plans for our empty Station. President Edwards asked that Summit Lake residents and SLCA be included on plans for the future of our empty Firehouse.

Davie Kendal has sent applications for Volunteers, but the criteria is set so high, it is doubted anyone in a volunteer status can meet the requirements.

Chief North is saying they have a 12.5-minute response from Station #91 to Summit Lake. Because of several serious accidents etc., we know the time to be over 25 minutes up to 34 minutes.

Summit Lake residents pay a premium rate in taxes and we receive very little services from anyone in Thurston County.

More information needs to be sent out to the community to get SL residents involved in the Fire Commissioners meetings. It is time to start putting some pressure on the Fire Commissioners. The meetings are the second Thursday of the month at 5:30. To speak, you have to call the Blacklane McLane fire department and ask Davie Kendall to put you on the Agenda. It is time for Summit Lake to speak up.

ON THE ROCKS FUNDRAISER -

On the Rocks did a fantastic job over Labor Day with their on the water concerts. On the Rocks gave SLCA a \$1200 donation for putting out their information to the Membership! Thanks so much!

PROPOSED CHANGES TO SLCA BYLAWS (Amended November 4, 2016)

Motion to change Bylaws by Terry Brannberg (submitted for Oct 2020 meeting, to be voted on Nov 2020 meeting per SLCA Bylaw change requirements).

Whereas the SLCA Bylaws (Amended October 5, 2018) contain numerous changes that were never approved by the Association other than one related to an increase in annual dues to \$60 per year, and whereas many of those non-approved changes and deletions are inappropriate, confusing, and/or typographical errors, I move that the October 2018 Bylaws be hereby rescinded, and the November 4, 2016 Bylaws be reinstated, and changed as follows:

- Change "(Amended November 4, 2016)" to "(Dated November 6, 2020)".
- Article I, PURPOSE Change the word "improvement" to "involvement"
- Article II, Section 2 Following the first sentence, add the words "Dues for 2019 shall be \$60. For 2020 and beyond, the", and delete the word "The" at beginning of next sentence.
- Article III, first paragraph Change the word "associations" to "Association", change the words "five Trustees" to "five to seven Trustees".
- Article IV, Section 2, second line change the words "SEC 1" to "SECTION 1".
- Article IV, Section 3, third line change the words "the next regular meeting and/or in the monthly newsletter" to "the next General meeting and/or in the next SLCA newsletter".
- Article IV, Section 4
 - * second paragraph, last sentence add the words ", credit card, or other properly documented method".
 - * third paragraph change the words "clubhouse repair" to "the Clubhouse repair" and change the words "a vote of the association members" to "a vote of the majority of the Association members".
- Article IV, Section 5
 - * First line change the words "five Trustees" to "five to seven Trustees".
 - * Fourth line change the words "two of five Trustees" to "two of the Trustees".
 - * Sixth line change the words "two or three Trustees" to "two to four Trustees".
- Article V
 - * Third line change the words "six (6) regular association meetings" to "six (6) General Association meetings"
 - * Fourth line change the words "Meetings shall be held on the first Thursday of the month" to "Meetings shall be held on the first Friday of the month"
 - * Seventh line change the words "notification to be given" to "notification shall be given".
- Article VI change the words "Not less than eleven members" to "Not less than twenty-one members".
- Article VII, Section 1, third paragraph change the words "Odd numbered terms start years (January date) shall have three Trustees elected; even numbered term starts years shall have two Trustees elected." to "Odd numbered term start years (January date) shall have three or four Trustees elected; even numbered term starts years shall have two or three Trustees elected.".
- Article VII, Section 2 -- Change the words "Any other office shall be filled by nomination and election at the meeting following that in which the vacancy occurs." to "Any other office shall be filled on a temporary basis by the Executive Board, with subsequent nomination and election to complete the term of office at the SLCA general meeting following that in which the vacancy occurs."

- Article VII, COMMITTEES Change Article number from "VII" to "VIII" to correct typo.
- Article IX, title Add the words "Changes or" ahead of the word "Amendments".
- Article XI, Section 1, items 1 and 2 change the word "offence" to "offense".

Notes:

- 1. Article I Better defines the Association purpose. Improvement and betterment are redundant.
- 2. Article II Dues change approved in November 2018 SLCA General meeting.
- 3. Articles III and VII -- Although we need more trustees, we should not lock ourselves in to seven trustees and be forced to fill slots on board just for the numbers.
- 4. Article IV, Section 3 -- We do not have a monthly newsletter (it's currently issued five times per year).
- 5. Article IV, Section 4 Change allows Treasurer to make payments by documented means other than paper check.
- 6. Article V Changes general meeting day to Fridays to agree with current schedules.
- 7. Article VI With a membership of almost 200, a quorum of only 11 makes no sense –suggestion is 21. The number of 11 was established back when there was almost no interest in the organization and the membership was much lower.
- 8. Article VII -- We need to be able to fill Trustee position on temporary basis as we did (apparently illegally) this summer by Board approval since we can have several months gap between general meetings.
- Article IX Changes and amendments are different. Changes are what we are doing here, whereas amendments are additions to the Bylaws as an Amendment sheet.
- 10. Other minor changes (some of which were derived from the 2018 changes) are included for procedural purposes, and to improve clarification / correct typographical errors.

Community Center Upgrades

Phase 1 projects are now complete, including upgrades to the parking lot with asphalt surfacing the portion closest to the clubhouse to improve parking and eliminate the constant mud holes in the parking lot near the clubhouse door. That also provided a smooth surface for the basketball and pickleball courts which are available for use by the membership.

Phase 2 upgrade projects on the SLCA property estimated at \$9500 were approved by the association membership during the October General Meeting, which included the building of a covered picnic area/ pavilion, adding some RV camping spots in the area cleared by the logging project, and some appropriate play equipment for kids. During the October meeting, the purchase and installation of a CONIX container for use as a storage shed (up to \$3500) was also approved in addition to the Phase 2 project.

A suitable CONIX container became available at a very reasonable price (\$200) through a contact of Vaughn Hodgins, and plans were made and implemented by the SLCA board to obtain the container, prepare a spot on the SLCA property for it, and have it moved into place. This was accomplished in late October, and the storage facility is now in place as shown in the pictures. With some interior modifications and built-ins (and exterior painting), it will soon be available for use, and allow some major decluttering of the Clubhouse, all at a cost of less than \$1000.

Stored items have already been removed from the back room behind the kitchen, and this area converted to use as a locked place to store and show Summit Lake logo items for sale. A big thank you to Craig Fuchs for his effort in building in the walls, doors, and shelving to Joni's specifications.

Planning for the other Phase 2 projects, starting with the 20 x 20 ft covered pavilion, is in work by the SLCA board, with actual work to proceed when the spring weather arrives, and the projects can be reasonably implemented.

Summit Lake Fire Station

STATION 93



The Summit Lake fire station is part of the McLane-Black Lake Fire district, and is described by them on their web site as follows:

"The western-most fire station, Station 93 is located on the north-western corner of Summit Lake. This station allows fast access to citizens that live in the rural area surrounding the lake, the State Route 8 Highway corridor, the Straddeline ORV park, and the wilderness area Capitol Forest. Six full-time Resident Volunteers live at the station."

This all sounds great for the Summit Lake and surrounding area, but unfortunately the facts are different. The picture is more representative of the current situation, with the station empty and no-one around. There are no Resident Volunteers, and the station is only staffed during times considered to be potential emergencies, such as severe storms. The SLCA board is currently conducting ongoing discussions with the Fire District officers and Commissioners about the situation, in hopes of resolving some of the issues and getting the station staffed to some reasonable level.

The following was provided by a long time Summit Laker regarding some of the history of the fire department at Summit Lake:

"52 years ago last Feb, my late wife Deana and I bought our lot on Summit Lake. When we came to look at 'our' lot we passed the fire station. It was burned to the ground! The volunteer fire department had acquired a used tank truck. A fireman went to the station to work on it. In working on it he discovered that the gas line was leaking, he immediately started it and drove the truck towards the door. Unfortunately he had left a trouble light on the running board. When it fell off the bulb broke, the gas ignited and the fire station, fire trucks and EMT vehicle were destroyed. Other fire departments loaned and donated equipment and the department was again working. A new building was built on the site. Fast forward many years and a firemen working on a fire truck drove out with a bin door open on the left side of a fire truck. It clipped the garage door and tore a part of the front wall out. Thurston County deemed the building unrepairable so it was totaled which I never understood. The building was torn down and the 3rd Summit Lake Fire Department building was built! The volunteer fire department acquired used a ambulance and rebuilt it and equipped it. We had a wonderful group of firemen and a good working fire department. Thurston county then said we could not have a volunteer fire department and staffed the station and mobile home with trainees and took ownership of all fire fighting equipment. When the new fire department was built we were promised full time staffing. I found you could knock on the door and call the number and get no one at times. We now have our 4th fire department building that is empty 100% of the time. I feel we deserve better than this. I lived for 40 years in Central Park just East of Aberdeen. They had full time fireman, a paid chief and volunteers, a good mix! Keep the heat on their feet until we get something for our tax dollars.

It has been an honor to serve as your fire chief for the last 18-years. After 40-years in the fire service, effective January 1, 2021, I am retiring.

I am extremely grateful for the support the department has received over the years from the Summit Lake Community. The installation of dry hydrants and acquisition of property from the Green Diamond Resource Company for construction of Fire Station 93, stand testament to that support. Sustaining and enhancing this community partnership is important for the department to meet the needs of the community now and in the future.

Last year, the closing of the Fire and Emergency Services Technology Program ended a partnership the department enjoyed with South Puget Sound Community College since 1991. The end of the program eliminated a readily available source of volunteer firefighters and has resulted in significant staffing challenges within our volunteer resident firefighter program districtwide. I am pleased the Summit Lake Community Association is working cooperatively with the department in our volunteer recruitment efforts. Chief Johnson has years of experience working within a combination fire department (career/volunteer) and is an excellent choice to lead the department. sets, wildlife in abundance, and the quiet days on the lake.








LAKE LIFE

Summit Lake is a natural glacial formed lake and is the deepest and clearest of the Thurston County lakes. This topographic view of the lake shows the lake depth in the different areas of the lake, with the maximum lake depth of 100 feet along the northern edge of the lake near and to the west of the dogleg bend. Almost half of the 511 acre lake is 80 ft or more in depth.

Great Blue Heron

We had a blue heron this fall that decided our dock was the ideal place to roost and watch for fish. He (or she?) was there almost

every morning, either close to shore watching the shallow water for small fish, or near the end of the dock just resting. It would stay there for a long period of time if not

disturbed, but just opening the sliding door to take a picture would send it on it way to somewhere else. I thought an article about the great blue heron might be of interest to the lake residents, so here is some information gleaned from a couple of sources.





Whether poised at a river bend or cruising the coastline with slow, deep wingbeats, the **Great Blue Heron** (*Ardea herodias*) is a majestic sight. This stately heron with its subtle blue-gray plumage often stands motionless as it scans for prey or wades belly deep with long, deliberate steps. They may move slowly, but Great Blue Herons can strike like lightning to grab a fish or snap up a gopher. In flight, look for this widespread heron's tucked-in neck and long legs trailing out behind.

The great blue heron is a large wading bird in the heron family, common near the shores of open water and in wetlands over most of North and Central America, the Caribbean, and

the Galápagos Islands.

The great blue heron is found as far north as Alaska and the southern Canadian provinces in the summer. In winter, the range extends south through Florida, Mexico, and the Caribbean to South America. Birds east of the Rocky Mountains in the northern part of their range are migratory and winter in the coastal areas of the Southern United States, Central America, or northern South America. However, their hardiness is such that individuals often remain through cold northern winters, as well, so long as fish-bearing waters remain unfrozen (which may be the case only in flowing water such as streams, creeks, and rivers).

Despite their impressive size, Great Blue Herons weigh only 5 to 6 pounds thanks in part to their hollow bones—a feature all birds share. Notable features of great blue herons include slaty (gray with a slight azure blue) flight feathers, red-brown thighs, and a paired red-brown and black stripe up the flanks; the neck is rusty-gray, with black and white streaking down the front; the head is paler, with a nearly white face, and a pair of black or slate plumes runs from just above the eye to the back of the head. The feathers on the lower neck are long and plume-like and the bill is dull yellowish. Immature birds are duller in color, with a dull blackish-gray crown, and the flank pattern is only weakly defined; they have no plumes, and the bill is dull gray-yellow. The heron's stride is around 8.7 in, almost in a straight line. Great Blue Herons have specialized feathers on their chest that continually grow and fray. The herons comb this "powder down" with a fringed claw on their middle toes, using the down like a washcloth to remove fish slime and other oils from their feathers as they preen. Applying the powder to their underparts protects their feathers against the slime and oils of swamps.

LAKE LIFE

The primary food for great blue heron is small fish, though it is also known to opportunistically feed on a wide range of shrimp, crabs, aquatic insects, rodents, and other small mammals, amphibians, reptiles, and birds, especially ducklings. Primary prey is variable based on availability and abundance. Herons locate their food by sight and usually swallow it whole. They have been known to choke on prey that is too large. It is generally a solitary feeder. Individuals usually forage while standing in water, but also feed in fields or drop from the air, or a perch, into water. Mice are occasionally preyed on in upland areas far from the species' typical aquatic environments. Thanks to specially shaped neck vertebrae, great blue herons can quickly strike prey at a distance. They can hunt day and night thanks to a high percentage of rod-type photoreceptors in their eyes that improve their night vision.

This species usually breeds in colonies, in trees close to lakes or other wetlands. Adults generally return to the colony site after winter from December (in warmer climes such as California and Florida) to March (in cooler areas such as Canada). Usually, colonies include only great blue herons, though sometimes they nest alongside other species of herons. These groups are called a heronry (a more specific term than "rookery"). The size of these colonies may be large, ranging between five and 500 nests per colony, with an average around 160 nests per colony. Heronry sites are usually difficult to reach on foot (islands, trees in swamps, high branches, etc.) to protect from potential mammalian predators. The female lays 3 to 6 pale blue eggs, which can measure from 2 to 3 inches in length. Eggs are usually laid at two-day



intervals, incubated around 27 days, and hatch asynchronously over a period of several days. Males incubate for about 10 hours of each day, while females usually incubate for the remainder of each day and the night, with eggs left without incubation for about 6 minutes of each hour. Both parents feed the young at the nest by regurgitating food. Parent birds have been shown to consume up to four times their normal amount food when they are feeding young chicks. By the time they are 45 days old, the young weigh 86% of the adult's mass. After about 55 to 80 days, young herons take their first flight. They return to the nest to be fed for about another 3 weeks, following adults back from foraging grounds, and are likely to gradually disperse away from their original nest over the course of the ensuing winter.
